CITY 1ST PRIVACY PROMISE TO CONSUMERS

CITY 1ST PRIVACY NOTICE TO CONSUMERS

Keeping customer information secure is a top priority for all of us at City 1^{st,1} This Notice tells you how we collect, handle, and disclose personal information about you. If you want to limit our disclosing this information, please see the **Privacy Choices Form** on page 5 of this Notice. If you are a joint applicant or mortgage holder with someone else, we will accept the **Privacy Choices Form** from either of you and apply it to the entire account. This Notice also applies to former customers and applicants, as well as to current customers unless we state otherwise.

Our Policies and Practices to Protect Your Personal Information

We protect personal information we collect about you by maintaining physical, electronic, and procedural safeguards that meet or exceed applicable law. As a current customer, you can learn more about how we protect this information by reviewing our **Privacy Promises** section on page 6 of this notice.

Personal Information We Collect and May Disclose

The personal information we collect about you comes from the following sources:

- Information we receive from you on applications or other forms, such as your name, address, and telephone number, as well as other financial information.
- Information about your transactions with us, our affiliates, or nonaffiliated third parties, such as your initial mortgage amount, mortgage type, payment history, and (for Home Equity Line of Credit Mortgages) account activity;
- Information we receive from a consumer reporting agency, such as your credit bureau reports and other information relating to your creditworthiness;

- Information we receive about you from other sources, such as your employer and other third parties, including employment history and income; and
- Information we receive about you during the verification process.

We may disclose any of the above information that we collect to affiliates and nonaffiliated third parties as described below.

Nonaffiliated Third Parties to Whom We May Disclose Personal Information

Nonaffiliated third parties are those who are not part of City 1st Mortgage Services or the family of companies controlled by City 1st Mortgage Services.

We may disclose personal information about you to the following types of nonaffiliated third parties.

- Financial services providers, such as companies engaged in consumer finance, securities, and insurance,
- Non-financial companies, such as companies engaged in direct marketing and the selling of consumer products and services.

If you check **Box 1** on the **Privacy Choices Form**, we will not make these disclosures except as follows. First, we may disclose information about you as described above in "Personal Information We Collect and May Disclose" to third parties that perform marketing services on our behalf or to other financial institutions with whom we have joint marketing agreements. Second, we may disclose personal information about you to third parties as permitted by law, including disclosures necessary to process and service your mortgage through City 1st, and also including disclosures necessary to consummate the sale of your mortgage to another mortgage servicing company and other public and/or private investors.
